If I buy a property at the Tax Auction, will I be responsible for any taxes? A. All tax liens which predate the Tax Foreclosure are extinguished by the Foreclosure, but by buying at the Auction you are agreeing to pay the School District and Village Taxes (if applicable) for the year in which the Auction is held.

Overview Properties in foreclosure are those that have tax that is more than \$100 (cumulative) and is three or more years delinquent. By law, the Pierce County Assessor-Treasurer must begin the foreclosure process by filing a Certificate of Delinquency on each of the delinquent properties with the Superior Court in Pierce County.

Foreclosures Delinquent Property Tax Sales. Wisconsin State Law provides for the transferring title to land when taxes are delinquent. The delinquency must be more than one year in Milwaukee County. Milwaukee County uses the "in rem" foreclosure process. Milwaukee County does not sell foreclosed properties for back taxes.
